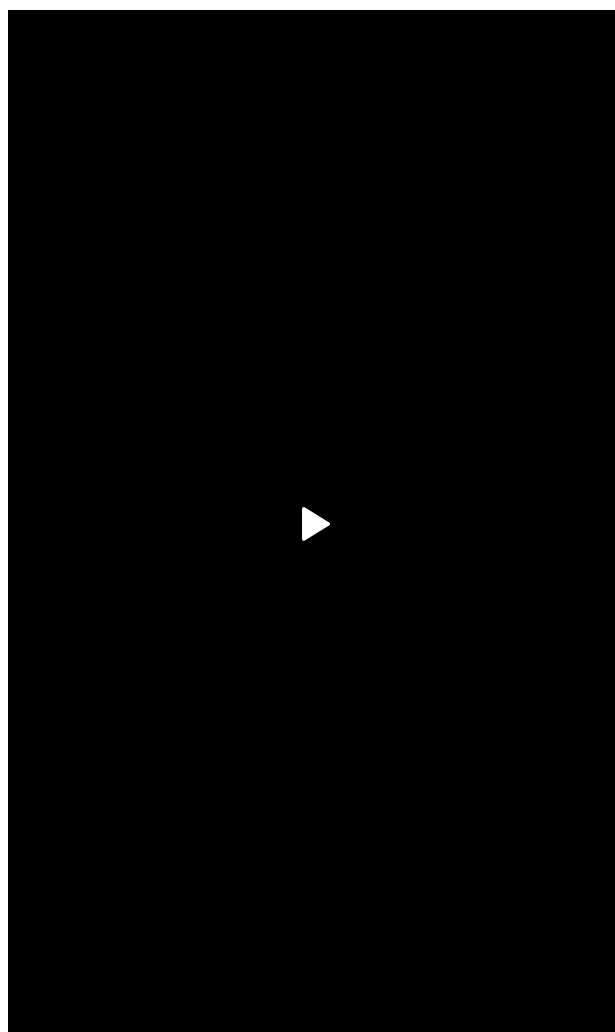


About Us

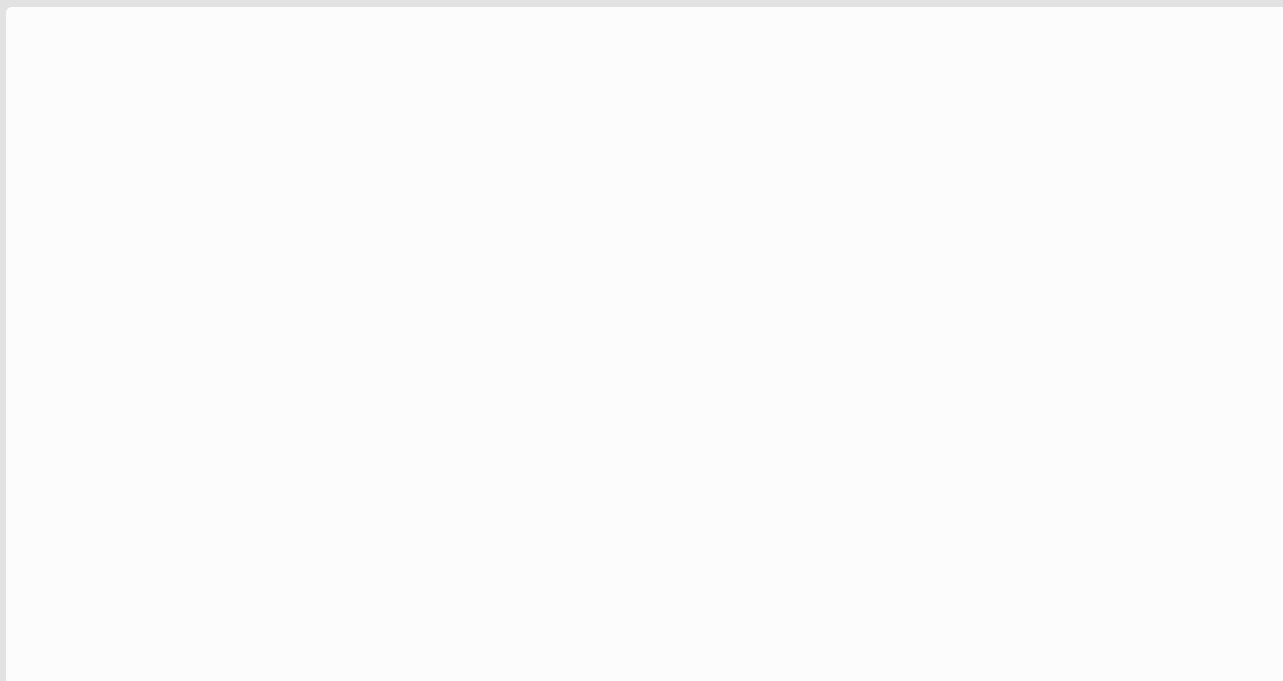
